Rent Paid by Direct Debit – Prize Draw

Terms & Conditions

1. The Rent Paid by Direct Debit Prize Draw (the "Prize Draw") is open to all North Lanarkshire Council house rent Direct Debit payers who:-
 - Have been paying rent by Direct Debit for at least 6 months immediately prior to the date of each draw;
 - Have not defaulted on the payment of rent within the 6 months immediately prior to the date of each draw.
2. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
3. To enter the Prize Draw you must sign up to paying rent for a council house by Direct Debit.
4. A prize draw will take place on (or around) the last working day of each calendar month.
5. Two winners will be chosen from a random draw of qualifying rent Direct Debit payers in accordance with these Terms and Conditions.
6. The winners will each receive shopping gift vouchers worth £250.
7. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
8. The name of the prize winners may be published on the Council's website/Facebook page/tenants' newsletter or other publicity material with the prize winner's agreement.
9. The outcome of the draw is final. No correspondence will be entered into concerning the outcome of the draw.
10. North Lanarkshire Council retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available.
11. North Lanarkshire Council accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason.

12. North Lanarkshire Council shall use and take care of any personal information you supply to it as described in its [privacy policy](#) and in accordance with data protection legislation. By entering the Prize Draw, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Prize Draw entry, and for the purposes outlined above.

North Lanarkshire Council accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Prize Draw or accepting the prize. North Lanarkshire Council further disclaims liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the Prize Draw. Nothing in these Terms and Conditions shall exclude the liability of North Lanarkshire Council for death, personal injury, fraud or fraudulent misrepresentation as a result of its negligence.

North Lanarkshire Council reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated, suspected or actual fraud). The decision of North Lanarkshire Council in all matters under its control is final and binding and no correspondence will be entered into.
15. North Lanarkshire Council shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.
16. The Prize Draw will be governed by Scottish law and entrants to the Prize Draw submit to the exclusive jurisdiction of the Scottish courts.
