(STOPPING UP OF THE FOOTPATH BETWEEN WISHAW ROAD AND GARRION GILL,  
WATERLOO, WISHAW) ORDER 2022

North Lanarkshire Council, incorporated under the Local Government etc. (Scotland) Act 1994 and having its principal office at Civic Centre, Windmillhill Street, Motherwell, ML1 1AB in exercise of the powers conferred upon them by Section 208 of the Town and Country Planning (Scotland) Act 1997 and all other powers enabling them in that behalf, being satisfied that it is necessary to authorise the stopping up of a footpath between Wishaw Road and Garrion Gill, Waterloo, Wishaw hereinafter specified in order to enable development to be carried out in accordance with works permitted under Part 23 of the Town and Country Planning (General Permitted Development) (Scotland) Order 1992 and having complied with the provisions of Schedule 16 to that Act hereby make the following Order:

- (1) This Order shall be cited as the North Lanarkshire Council stopping up of the footpath between Wishaw Road and Garrion Gill, Waterloo, Wishaw Order 2022 and shall come into operation on the date of confirmation or such other date as may be appointed by the Scottish Ministers.
- (2) In this Order:  
“footpath” means the area shown cross hatched on the plan annexed and subscribed as relative to this Order.  
  
“development” - means the demolition of the Gill occupational bridge by Network Rail.
- (3) The stopping up of the said footpath is hereby authorised.
- (4) Network Rail registered office 1 Eversholt Street, London, NW1 2DR has agreed to meet the costs of making and advertising this Order.

- (5) Where, immediately before the date of this Order there are any rights of Statutory Undertakers in respect of any apparatus of theirs which is under, in, on, over, along or across the footpath, such Undertakers shall thereafter, without prejudice to the provisions of Section 224 of the Town and Country Planning (Scotland) Act 1997, as read with Section 213 of that Act, have the same rights in respect of that apparatus as they had immediately before that date.
