



Notice of Right to Review to North Lanarkshire Council in relation to the former Cumbernauld Theatre site, Kildrum, Cumbernauld.

I write as a representative of Cumbernauld Cottage Trust (“the organisation”) and in relation to a notice from North Lanarkshire Council rejecting a community asset transfer of the Property to the organisation (the “Decision”).

This letter serves as a notice of right to review under section 86 of the Community Empowerment (Scotland) Act 2015. We are appealing on the basis that our request to purchase the Property has been rejected following consideration by North Lanarkshire Council, and submit that this decision was taken on incorrect or incomplete information.

Introduction:

Below is the response from Cumbernauld Cottage Trust, hereafter “the Trust”, to the reasons given by NLC for refusing the Trust’s CAT application. NLC’s statements are in italics at the top of each Section.

Section 1. Potential for duplication of service:

The case for the transfer of the asset is built upon a service delivery model that is likely to create duplication with existing services that the council has already invested in. The application does not adequately refer to how the services being offered as part of the CAT proposal add value to those already being delivered via other local venues and organisations in the Cumbernauld area, nor does it explore or evidence through market research that the potential for competition regarding income streams has been considered. Any duplication could undermine the financial projections and reduce the Trust’s ability to meet income targets.

Trust Response:**a. Lanternhouse**

- There is no duplication of service with Lanternhouse. We support Lanternhouse and are pleased to have this facility in Cumbernauld. However, it is not a Community Hub, it is a performing arts venue.
- The Trust intends and expects to work collaboratively with various third sector organisations in the area, including Lanternhouse. As will be shown below, we have already developed good collaborative working relationships with many local organisations and groups.
- The Trust shares two Board members with Cumbernauld Theatre Trust/Lanternhouse, and other Board members are regularly involved with activities offered by Cumbernauld Theatre at Lanternhouse. The Trust was thus well-placed from the beginning to ensure that there was no duplication or competition.
- Informal discussions with Lanternhouse personnel indicate potential for partnership working in the form of collaboration and complementary provision. For example, in September 2023, Cumbernauld Town Hall (an NLC venue) is being used to host comedian Karen Dunbar, as the date clashed with another performance at Lanternhouse. As Cumbernauld Town Hall is scheduled for demolition over the next 5 years as part of the redesign of Cumbernauld Town Centre, the Cottage could provide similar satellite accommodation to alleviate pressure on theatre space at busy times in the year, while still bringing popular performers to Cumbernauld.

- We believe that NLC's repeated reference to the building as the "Former Cumbernauld Theatre" has led to confusion. The Trust has proposed that the Cottage be turned into a Community Hub: we are not proposing that the Cottage will be a theatre, nor a cinema, nor a venue for professional or semi-professional music.
- Services offered by the Cottage would be on an entirely different scale to those provided by Cumbernauld Theatre at Lanternhouse. Lanternhouse is a professional producing and receiving house, well established as part of the Scottish arts scene, supported as an RFO by Creative Scotland and working in close partnership with the local authority. While Lanternhouse provides a community programme in its performance classes, it is not an open Community Hub that can be accessed daily by the public for chosen activities and purposes.

The Cottage would be an open Community Hub that offers local and easily accessible space for community groups and activities, for affordable meeting, practice, and rehearsal space, and as a venue for local people to celebrate family and social occasions. The Cottage would be a community and social space, not an arts venue.

- Lanternhouse draws its audiences from a much wider area within Cumbernauld, and indeed from areas outwith Cumbernauld. The Cottage will have a more local customer base, mostly from within Seafar, The Village, and Kildrum.
- Café / bar facilities at Lanternhouse do not meet community need for various reasons, including limited opening hours (10am to 4pm on weekdays only). Lanternhouse's café is situated in a school campus, away from the main housing areas of Kildrum, so is not able to attract passing trade, whereas the Cottage would. The Cottage café would anticipate being open 7 days a week, including in the evenings.
- Lanternhouse does not have community music facilities. The Lanternhouse programme encompasses professional music performance, and no participatory opportunities are offered (e.g. guitar lessons or choir) as part of the theatre's provision. No local music groups feature in the programme, with the exception of Cumbernauld Musical Theatre Society. Local amateur musicians currently have no local performance space available to them, following the recent closure of a town centre venue.
- Spaces for hire are notionally available at Lanternhouse for community use, but the provision of hired space in Lanternhouse is (understandably) limited by the inhouse use of existing space. When space is available for external groups to hire space, the hire charges at Lanternhouse are greatly in excess of other facilities in the town, which makes them inaccessible for community groups.

b. Duplication of Service with other venues

- Kildrum lacks a multi-purpose Community Hub. While the area houses the YMCA, it is limited in its function and does not offer an open-door service day to day, nor does it offer a café facility for refreshment and social gathering. As noted above, parts of Seafar and The Village, as well as other nearby areas, will also benefit from the Cottage facility as a Community Hub.
- The map provided by NLC is not particularly clear in identifying the facilities and services within the Kildrum area that provide the community and social hub the Cottage is looking to provide. We submit that the lack of clarity is because there are none.
- The Cottage cannot be compared to a school or a library, neither of which provide community and social space. Kildrum does not have a library.
- The map from NLC refers to warm spaces which The Trust understands are no longer operational, and have not been operational since 31st March, some two months prior to the CAT being refused. Therefore, we submit that the Committee was provided with out-of-date information about how much community space is available in and around Kildrum.
- Other community spaces offered by NLC are limited. The only NLC venue in Kildrum (Braehead Rooms) is permanently closed. The Muirfield Centre seems to be operating at capacity as it is difficult to secure a booking in there. Other council-run community rooms and centres offer limited opening hours. There are none locally available in the Kildrum area, apart from Lanternhouse.
- Access to affordable community space will be further reduced by the future closure of the Town Hall and The Link, as part of the pending regeneration of Cumbernauld's Town Centre. We understand that the Town Centre regeneration is due to happen over a period of 5+ years, which allows the Trust to get the Cottage renovated and established in time to fill this gap in services.

Section 2. Project Delivery:

While there is reference to staffing and management around service delivery at the point that the project is operational, it is unclear how the project would be robustly managed throughout the early stages including attracting and securing capital investment, procurement, and construction. A project of this scale, risk and cost requires to be carefully

project managed. The submission does not reflect this or provide full consideration of the operating model and ensuring that this is sustainable and can balance the required generation of capital investment, building and construction with the likely need for phased delivery and maintenance (including the potential for further decline for areas of the site that resource may not allow to be prioritised for delivery).

Trust Response

- It is difficult to have firm offers of funding for capital work on a building that the Trust does not own. However, we have received expressions of interest from a number of funding organisations with proven track records in this field and who have supported similar projects. We anticipate using the support available through COSS, Scottish Land Fund and other funders, such as the Heritage Lottery Fund, with which we have entered into dialogue (verbally and face to face) with a view to generating an application for a substantial level of capital funding.
- If the Trust's CAT Review is approved, it would automatically trigger a review and redevelopment of the Trust's business plan, which would in turn lead to the development of detailed project plans. We are working with an accountant on revising our costings and have received funding from COSS Expert Advice fund to do so.
- The Trust has a strong Board of Management, comprised of individuals with a wide range of skills and experience. The professional competencies of most Board members include project management at various level. Two Board members are qualified legal professionals with many years of experience relevant to the management of property. Three Board members have specific experience of liaising with architects and contractors and management of projects related to the redevelopment of older buildings and associated construction work. One Board member has around 10 years of experience of building renovation, working closely with contractors to oversee the work on renovation of older buildings and, prior to retirement, was a member of the British Institute of Facilities Managers.
- The project will follow standard construction procedure, in that it will be fully scoped and go out to tender. The construction work will be on a phased basis, as detailed in the CAT application. It is standard that the architect or construction firm will have a Project Manager to oversee the construction project, and the Board will liaise regularly with that professional.
- Dialogue with the Scottish Land Fund towards a 2nd Stage application has identified the potential for funding to employ a Development Worker to assist the Board with community engagement and service planning and development. The Trust intends to employ a Facilities Manager and Development Manager as soon as funding can be

sourced to partly cover salaries during the initial period as income streams from trading activities and project working are gradually established.

- We share NLC's concern that a long CAT appeal process risks further decline of the site. If the building is occupied there is less potential for areas of the site to further decline as they await development. It is not in the Trust's interest to allow this. Therefore, it is essential that the appeal process is expedited to ensure that further decline to the site is mitigated.
- The Trust is confident that the operating model is financially sustainable as the space offers potential for a number of different uses. We have spoken to a number of organisations who are interested in using the Cottage on a long-term basis. These include an organisation supporting young adults with Additional Support Needs who are leaving the school system, and an organisation that supports victims of domestic abuse. Kildrum Community Council also anticipates using the venue regularly for community events.
- The location is also advantageous for attracting passing trade to the proposed café, as the Cottage is adjacent to Cumbernauld House Park and will attract dog walkers and others using the park for recreational purposes. It is located on a main walking path through Cumbernauld, from The Village through Kildrum and Seafar to the Town Centre, as well as a main access path from these areas to the Park.

Section 3. Evidence of Need/Community Benefit:

There was some community engagement through public meetings in 2018 and a survey in 2019. The survey received 1500 responses, (3% of Cumbernauld population). This was pre pandemic and prior to the opening of the new theatre site in 2021. There is little evidence in the application of more recent engagement or assessment of need reflecting current provision and changes in behaviour/trends arising from the Covid-19 pandemic or indeed the impact of the recent cost of living crisis. The council has witnessed a 50% drop in use post pandemic in its own community facilities, with a slow rise in activities through recovery. This information could inform a negative impact on the ability of the Trust to meet projected income targets from lets, hiring of space and community use of income generating activity such as the café.

Trust Response

a. Community Support

- It is unreasonable for NLC to consider the percentage of the entire population of Cumbernauld – Scotland’s 5th largest town – when it was never envisaged that the Cottage project would support the entire population of the town.
- The proposed Community Hub will largely be for the benefit of residents and visitors to Kildrum, Seafar and The Village. Public support of this project has been consistently high, as can be seen from our social media engagement. As mentioned above, we have also had positive expressions of interest from a number of third sector organisations who currently do not have a space in Kildrum for their work.
- Since NLC rejected the CAT application, we have received hundreds of supportive comments from individuals, as well as local community groups and organisations (Appendix A). Additionally, the Trust’s Open Letter, started May 2023, to NLC, calling on the Council to accept the CAT application at the Review stage, has been signed by over 2400 people to date (Appendix B). A further 56 people without internet access signed a hard copy of the Open Letter at Cumbernauld Gala Day (Appendix C).

- The Trust has a good working relationship with local radio station Cumbernauld FM, which has supported our efforts to maintain awareness of our work amongst the local community. The Trust has a regular presence at community events, raising awareness and recruiting new members.
- The Cottage buildings themselves have a cultural significance to the people of Cumbernauld, something that should not be dismissed by North Lanarkshire Council as sentimentality. The Cottage is part of Cumbernauld’s heritage, and is important to residents of Cumbernauld. While current interest appears to be focussed on the Antonine Wall and the Roman influence some 2000 years ago, many residents of Cumbernauld also value the more recent history of Cumbernauld, of which very little has survived.
- NLC does not have a heritage strategy so does not appear to have a methodology in assessing the importance of historical building and landscapes to the people that live around them. This is not about whether the buildings have national significance: it is about the values attached to them by the local community. The national strategy for our historic environment, Our Place in Time, outlines that it is an intrinsic part to our sense of place and cultural identity and helps to tell our shared story. The Cottages

may not tell a national story, but they do contribute to the story of Cumbernauld prior to the development of the new town.

b. Kildrum and LOIPs

The CAT would support the ambitions of The Plan for North Lanarkshire and specifically the Local Outcome Improve Plans (LOIPs) for Cumbernauld. Through the LOIPs, Kildrum has been identified as one of the three areas that would benefit targeted action, as residents are more likely to experience social inequalities than in other parts of Cumbernauld. Kildrum has pockets of severe deprivation, and also has the highest proportion of older people in any area in Cumbernauld, as many residents have been here since the new town was built.

Within the LOIPs document it is stated that NLC will

- target action to build the capacity of local organisations to enable them to take local action and ensure the voices of Kildrum are heard through Community Board and other decision-making processes.
- undertake activity to better understand Kildrum and the local assets, challenges and opportunities.

As a local organisation, The Cottage Trust has identified the need within Kildrum for community spaces.

- The LOIPs aims to provide **places where people can come together for a range of activities that will help to reduce social isolation and community inequalities.**

Currently, there are no facilities for the community to get together, no licensed premises, no community halls and no café. The CAT proposal uses the Cottage, a local asset, to satisfy this need.

- The LOIPs also look at greenspace maintenance and environmental quality, with the aim of encouraging more people to use well maintained outdoor spaces for leisure, recreation, and health purposes. Cumbernauld was designed for residents to have access to quality greenspaces and the Glen and Cumbernauld House Park are excellent examples of this. However, they suffer from a lack of facilities, which limits the amount of time that visitors can spend enjoying the area. The Cottage has the potential to address this issue. For example, people could go for a walk and then go to the Cottage for a coffee: Palacerigg Golf Club's popularity with dog walkers is a model for how successful this can be.
- The LOIPs plan pledges to **support the work of local communities to identify health and community inequalities.** The provision of a local meeting place will contribute towards an improvement in the health and wellbeing of local residents, many of whom have seen their mental health decline as a result of isolation and loneliness exacerbated by the Covid lockdowns. A community facility easily reached on foot or

by public transport would give people a focus for rebuilding relationships within their communities.

- The plan also states the intention **to work with partners at a neighbourhood level to ensure that residents of Kildrum feel able to participate, influence and take action to ensure that the priorities within Cumbernauld and associated actions benefit them.** Kildrum residents are very keen for a community hub in the Cottage. The Cottage Trust would be delighted to contribute towards the delivery of NLC LOIPs objectives.
- Targeted action is planned by NLC to **build the capacity of local organisations to enable them to take local action and ensure the voices of Kildrum are heard through Community Board and other decision-making processes.** Refusal to allow community ownership of an asset needed by the community cannot be described as building capacity to enable local action.

How the Cottage would deliver LOIPs in Kildrum

- It would target a range of social and community needs encompassing LOIPs. It would improve mental health by reducing loneliness and isolation. Feedback from recent events held by Kildrum Community Council clearly indicated that loneliness and isolation is an issue. The older population of Kildrum would welcome a local facility where they could meet informally.
- It would benefit physical and mental health by encouraging walking and other outdoor pursuits in the adjacent Cumbernauld House Park.
- Furthering LOIPs goals, many of the third sector organisations who have expressed interest in using the facility are directly working on the range of issues covered in LOIPs. For example, a domestic abuse organisation has stated that they prefer to meet service users in the community to reduce stigma, and that the Cottage would be an ideal venue.

4. Financial viability: *Overall, the capital works to bring the building into operation and the expected income generation from operation of the services planned are aspirational. The application did not provide sufficient reassurance of the financial sustainability of the project to balance the potential risk to the council of transferring the asset. There is no evidence that costs provided have been assessed in the context of the current 'cost of living and 'energy' crisis and how these may impact on the operating costs in the short/medium term. Additionally, the offer of £20,000 to purchase the asset is below market value, therefore requiring the applicant to evidence substantial community benefit which balances with the level of discount. The application in this case does not strongly enough evidence that the planned 'offer' to communities adds value to, compliments or provides an alternative to*

existing provision. The projected income generation does not reflect comparable incomes levels of sites operated by the council providing similar service provision.

Trust Response:

a. Our financial plans

- The Trust is unsure of the “potential risk to the Council” to which the response refers. A more detailed definition of this threat would be helpful in understanding NLC’s position. As far as we are aware, NLC has already divested itself of most of its responsibilities in relation to the site, and demolition is a very real prospect for this historic building.
- The report calls our plans “aspirational”. We agree: it is necessary for a project such as ours to have a vision of the desired end product and clear objectives. Our business plan sets these out. The Trust does not regard our Business Plan as a static document but rather one which will grow and evolve, and be refined in the context of the development of our project. The redevelopment work and introduction of service availability has been planned in three phases to allow for maximum flexibility in the face of the uncertain economic landscape.
- Our business plan is currently under review by a firm of accountants. At the time of the CAT application neither the Trust, nor any other body, foresaw such high inflation, nor the increase in Cost of Living or energy costs. It seems unreasonable of NLC to criticise the Trust for this, when our CAT application was submitted prior to these events. We agreed to NLC’s request for an extra 6 months in order for officials to properly scrutinise the application. This should not now be used against us.

b. Community Benefit offset

The Trust is willing to negotiate with NLC on the purchase price. This notwithstanding, we argue that the Cottage would bring sufficient community benefit to justify the difference between our offer of £20k and NLC’s market value price of £45k.

- It is felt the offer of £20K reflects the social benefit that the proposed Community Hub would offer the community, as outlined below.
- Significant investment is required in the building to bring it to the standard required for a community hub, and this is also reflected in our £20K offer.
- As the community hub at the Cottage becomes established, we foresee being able to offer training and employment opportunities to the community. This would include offering SVQ training in the café and garden, such as is offered at Twechar’s Healthy Living and Enterprise Centre.

- The Trust’s focus would be on working with local businesses and suppliers, to ensure that all spending is fed back into the local community.
- At present, as there is no community space, there is no “existing provision” [NLC’s words, above]. The Cottage would be the only such provision in Kildrum. The Trust anticipates that the Cottage would be available seven days a week, including school holidays, enhancing the provision currently offered in some of NLC’s existing community centres that serve Cumbernauld.
- The location of the Cottage as a cafe/bar would be ideal as it is close to Cumbernauld House Park and to a large number of residences in Kildrum, Seafar and the Village. It would provide a centre for socialising seven days a week. The cafe at Lanternhouse is not open at weekends or in the evenings.
- The nature of the Cottage, as a historic building in its woodland setting, with a café/bar facility, would enhance the attraction of the Cottage for visitors as a preferred destination, both for activities and casual use. We anticipate that this will be further enhanced when we reach the stage of opening the garden area.

5. Potential for ongoing maintenance burden/revenue implications for the council: *The submitted request does not include the group taking on maintenance of the associated car park and access road which service the site and provide access to the parking provision for the buildings. The CAT application includes part but not all the car park area. Agreeing to these terms may create a maintenance burden and liabilities for the council where there is not currently an operational budget associated with this asset. The closure of the site was assumed following the relocation of the provision to an alternative location. It would be challenging and complex to consider the transfer of the building in isolation from the car park and access road.*

Trust Response:

- The project is envisaged to be self-funded, with no financial burden on NLC beyond that for which it is currently liable. It is unrealistic to expect a small-scale community organisation to accept a major part of the burden of maintenance of a publicly used road and car park.
- If the closure of the Cottage site is seen as concluding any operational burden on NLC relating to the road and car park, we do not understand why these have not already been closed off. We suggest that NLC is fully aware that the car park is well used by local residents and visitors, as well as being used by NLC for maintenance access.

- The Trust is willing to negotiate with NLC on this matter, but cannot consider purchase of more than the portion of the car park delineated in the application.
- The Trust has been advised that transfer of the Cottage without the full carpark and access road should be a straightforward process and should not be unduly difficult for NLC.
- The rear car park is used by residents of Braehead Road, where there is insufficient parking. An average of 20 cars regularly park in the rear car park. The access road will continue to be used by these Kildrum residents, because of lack of parking availability in Braehead Road. Therefore, the access needs to be maintained to a reasonable standard to prevent damage to residents' vehicles (and associated additional costs to NLC). By continuing to maintain the access road, NLC will avoid the cost of providing additional parking in Braehead Road.
- To have access to the play area at Braehead Road - which is being enlarged - and the rear car park, NLC would still require use of the access road for maintenance staff and vehicles.
- The access road will also be required for maintenance of the various footpaths in the area, including from Cumbernauld House Park and Seafar.
- The rear car park is also used as an overflow carpark by visitors to Cumbernauld House Park and Glen. The only other provision is a small car park adjacent to Cumbernauld House, intended to serve the allotments as well as leisure users of the parkland. This is often full.
- The vehicles accessing and egressing the rear car park would be driving over the Cottage car park, thus causing further wear and tear damage. The Trust will be happy to allow this as a benefit to these residents but should not have to bear the cost of maintenance.
- The Trust has no responsibility for the rear car park, for the lack of parking in Braehead Road, nor for maintenance of NLC's paths and Braehead Road play area. It is unreasonable to expect the Trust to bear the burden of maintenance of the access road and car park to which NLC requires continued access in order to service NLC's own property.

To whom it may concern,

I am writing to express my support to Cumbernauld Cottage Trust with their application to North Lanarkshire Council for the Community Asset Transfer of the Cottage buildings. I understand and fully support the Trust's appeal against the Council's recent decision to reject their application.

Kildrum has lost many community facilities over recent years, including a Primary School, Braehead Road Community Flat, and Tennis and Putting facilities. Like other areas, it is in the process of recovering from the Covid crisis, and many adults and children are currently experiencing mental health difficulties, social isolation, and loneliness.

It is well recognised that social integration, the opportunity to meet, along with outdoor activities go a long way to help with individuals and families well-being.

The Cottage would meet these needs by providing a community meeting place including a cafe, and would enable and encourage the community to make use of the park through walking, cycling, running etc.

The availability of the Cottage provides a unique opportunity to develop a community space to meet the expressed demands and needs from and for the people of Kildrum and Cumbernauld.

As a community worker in Cumbernauld, I am acutely aware that spaces like this are essential for the community's health and well-being, and a policy of denying the community the opportunity to create and maintain spaces where they can gather and do things together will cost more in negative outcomes the long-run, than it would cost to maintain the spaces themselves. And that is without mention the suffering that individuals will experience from not having healthy community. The prevention of such unnecessary suffering ought to be the NLC's first priority. Healthy communities are essential to having healthy populations, and healthy communities need adequate spaces. The community of Kildrum needs and deserves to have this one.

I am appalled and disappointed that North Lanarkshire Council have rejected the Cumbernauld Cottage Trust's application for a community buyout to retain the Cottage Theatre buildings as a community asset. Having seen the detailed proposals and feasibility studies that the Cumbernauld Cottage Trust have produced I cannot agree with the decision that these plans are based on 'sentimentality' and I find it hard to believe that the local community aren't crying out for a community space. Cumbernauld's original plans included community rooms, local shops and pubs in each area, creating a sense of community and identity. The lack of facilities for the Kildrum and Seafar communities means that what facilities are available are overstretched and often unavailable. The Studio Arts Forum used to meet in the Studio Theatre before Cumbernauld Theatre relocated to it's new site and now uses space in Muirfield but how many small groups haven't been able to find accessible, local space to meet? The lack of a local pub in the area means meeting places are limited or non-existent. The long-term effects of the Covid lockdowns taught us that connection and community are essential for the well-being of us all and I am sure you are aware that community assets are one of the many key points in assessing Scotland's progress towards the development of a wellbeing economy so granting a community asset buyout to Cumbernauld Cottage Theatre Trust would only be beneficial to all both now and in the future.

Kildrum Community Council is fully in support of your review application to North Lanarkshire Council for the CAT transfer of the Cottage.

Kildrum has a high percentage of elderly residents, and feedback from recent events organised by the Community Council indicates that residents appreciated being able to go to a local venue as many felt isolated and lonely. Since the Braehead Community Rooms were permanently closed several years ago, there are no community premises in Kildrum. We would like to host regular events to tackle some of this isolation and loneliness, and thus improve mental health and wellbeing in the area, but we do not have a suitable and affordable venue to do this. The Cottage Trust's vision for the Cottage is exactly what we are looking for.

There are few facilities for older children and young adults in Kildrum, which Kildrum Community Council understands is partly responsible for the increase in anti-social behaviour in the area. Young people have nothing to do and nowhere to go. There is no access to the football pitch at Cumbernauld Primary School and little enthusiasm, it seems, for the basketball court as it is used for football. The Cottage could provide a base for organisations working with young people to carry out their work. This would improve the lives of the young people in the area, and also the wider community.

Kildrum has substantial pockets of deprivation, and is one of three target areas in North Lanarkshire Council's LOIPs initiative for Cumbernauld. The Cottage would provide a key location for organisations working on this initiative, and also for other third sector organisations working in Kildrum.

The considerable support from local residents was expressed very vocally at the most recent (May 2023) Kildrum Community Council meeting and frustration in the Council's decision was palpable. As NLC will be able to see from our Minutes, the residents of Kildrum feel very strongly in favour of the CAT – it has been raised as an agenda item at every meeting since KCC resumed in October 2022. They want and need a community hub in Kildrum, and they feel very ignored and let down by North Lanarkshire Council's decision.

We want and deserve to have friendly, healthy community spaces that support the local community, reduce isolation, and provide us with local space for community projects and socialisation.

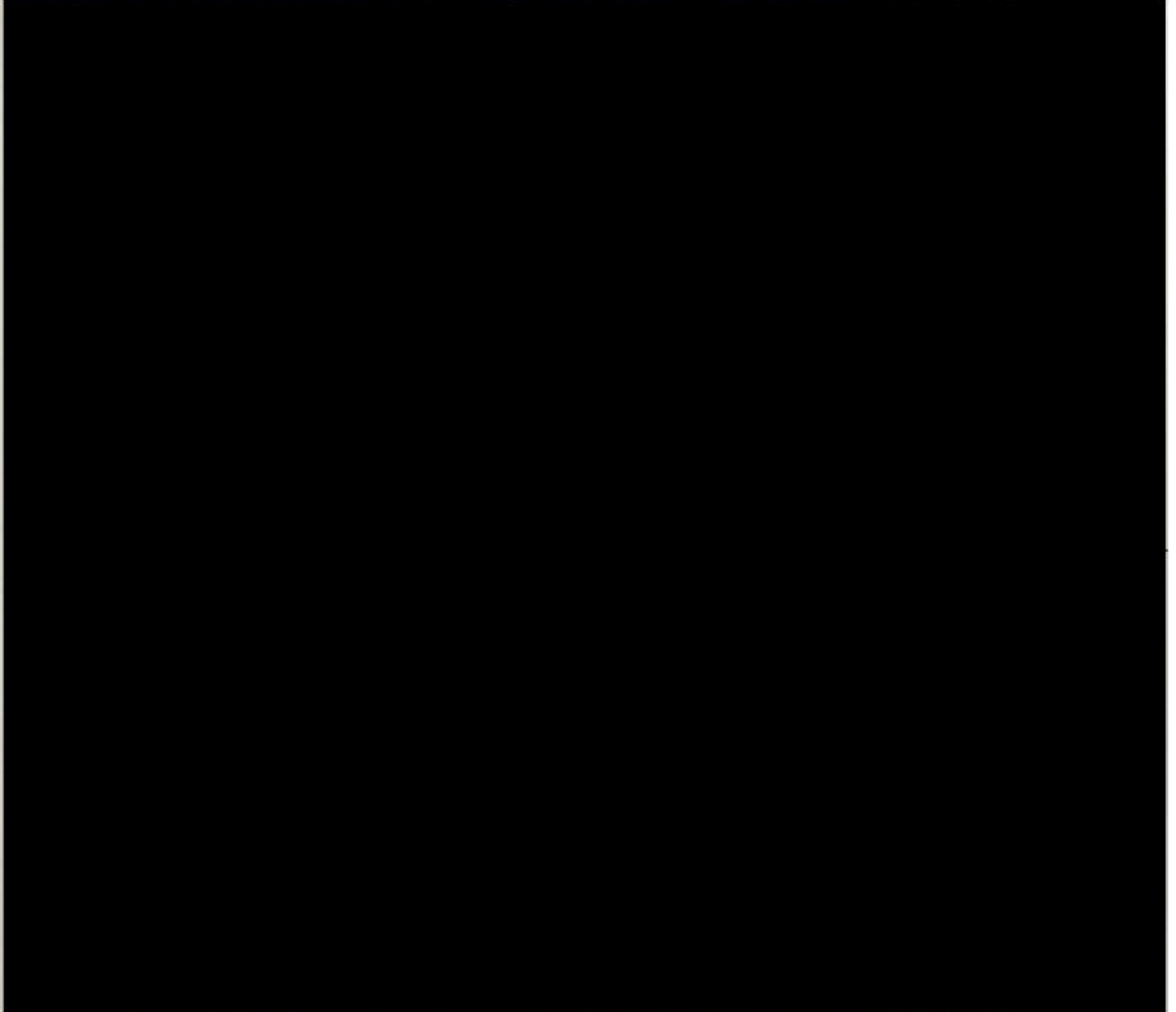

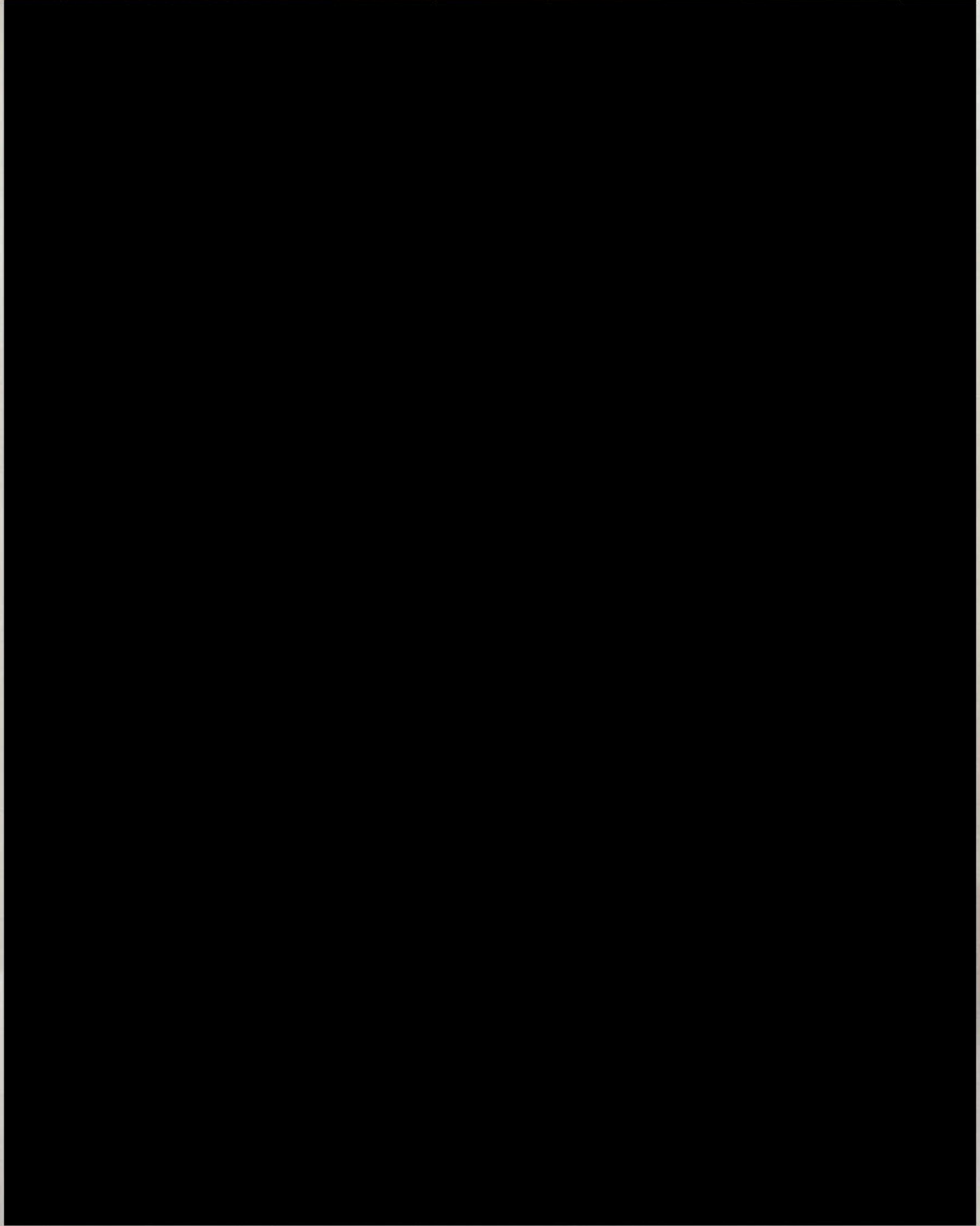

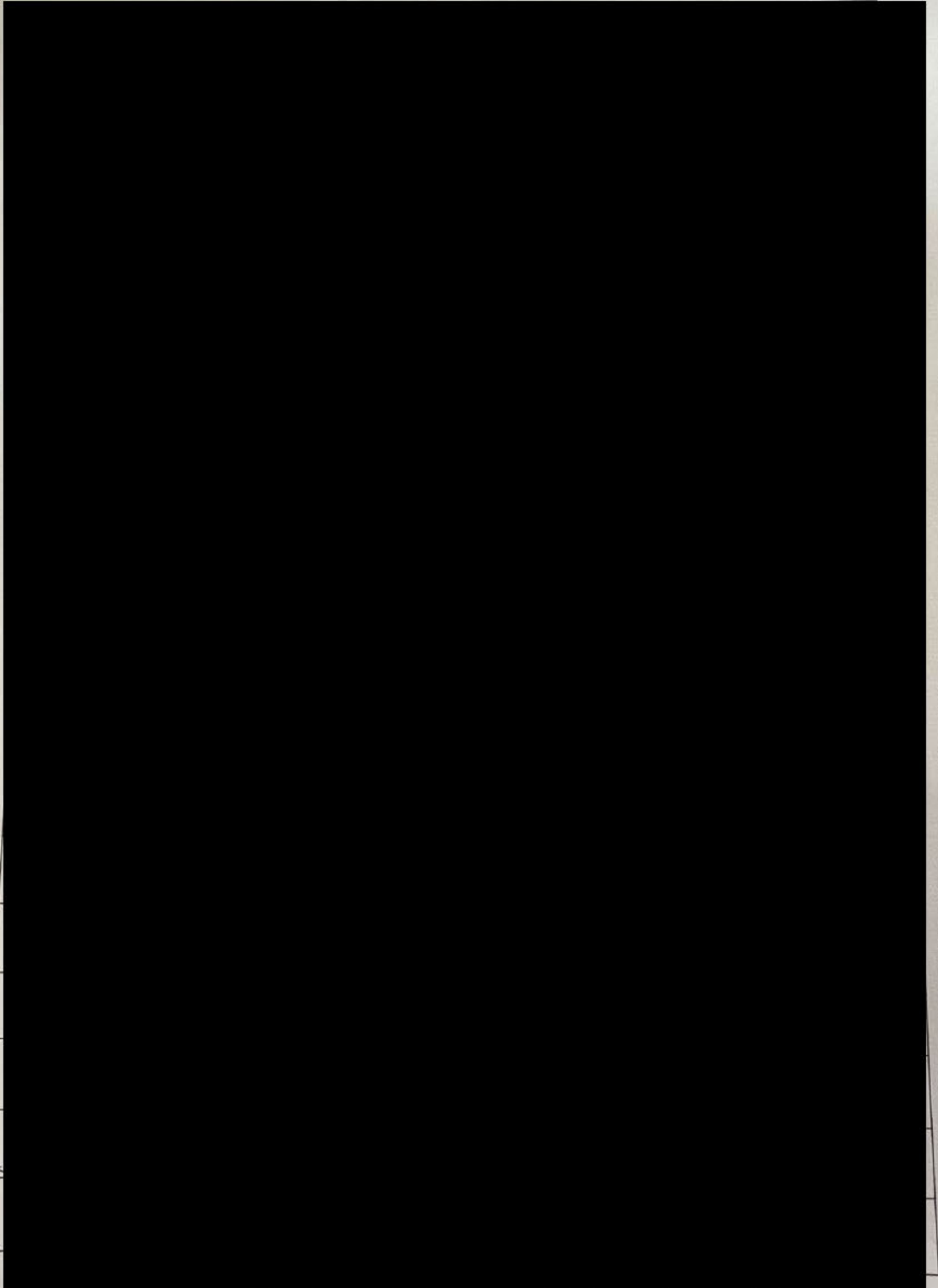
