STOPPING UP AND DIVERSION (PART OF FOOTPATH AT
ARDGOIL DRIVE, CUMBERNAULD) ORDER 2026

North Lanarkshire Council, incorporated under the Local Government etc. (Scotland) Act 1994 and having its principal office at Civic Centre, Windmillhill Street, Motherwell, ML1 1AB in exercise of the powers conferred upon them by Section 208 of the Town and Country Planning (Scotland) Act 1997 and all other powers enabling them in that behalf, being satisfied that it is necessary to authorise the stopping up and diversion of part of the footpath. Part of the existing footpath will be stopped up at two areas and a new diverted footpath will be created to allow a new access road to be built as part of the development to be carried out in accordance with planning permission granted under Part III of that Act and having complied with the provisions of Schedule 16 to that Act hereby make the following Order:

(1) This Order shall be cited as the North Lanarkshire Council Stopping Up and Diversion (part of footpath at Ardgoil Drive, Cumbernauld) Order 2026 and shall come into operation on the date of confirmation or such other date as may be appointed by the Scottish Ministers.

(2) In this Order:

“footpath” means the two areas shown coloured grey and described as “footpath to be stopped up” on the plan annexed and subscribed as relative to this Order.

“development” - means the erection of two class 3 (food & drink) units with associated landscaping and parking more fully described in Planning Application 25/00089/FUL.

"diverted footpath" – means the area coloured black on the plan annexed and subscribed as relative to this Order.

"new access road" means the area shown hatched on the plan annexed and subscribed as relative to this Order.


- (3) The Stopping Up and Diversion of the footpath is hereby authorised.
- (4) Pequod Cumbernauld Limited, 4 Oxgangs Road, Edinburgh EH10 7AU has agreed to meet the costs of making and advertising the Notice and Order.
- (5) Where, immediately before the date of this Order there are any rights of Statutory Undertakers in respect of any apparatus of theirs which is under, in, on, over, along or across the footpath, such Undertakers shall thereafter, without prejudice to the provisions of Section 224 of the Town and Country Planning (Scotland) Act 1997, as read with Section 213 of that Act, have the same rights in respect of that apparatus as they had immediately before that date.

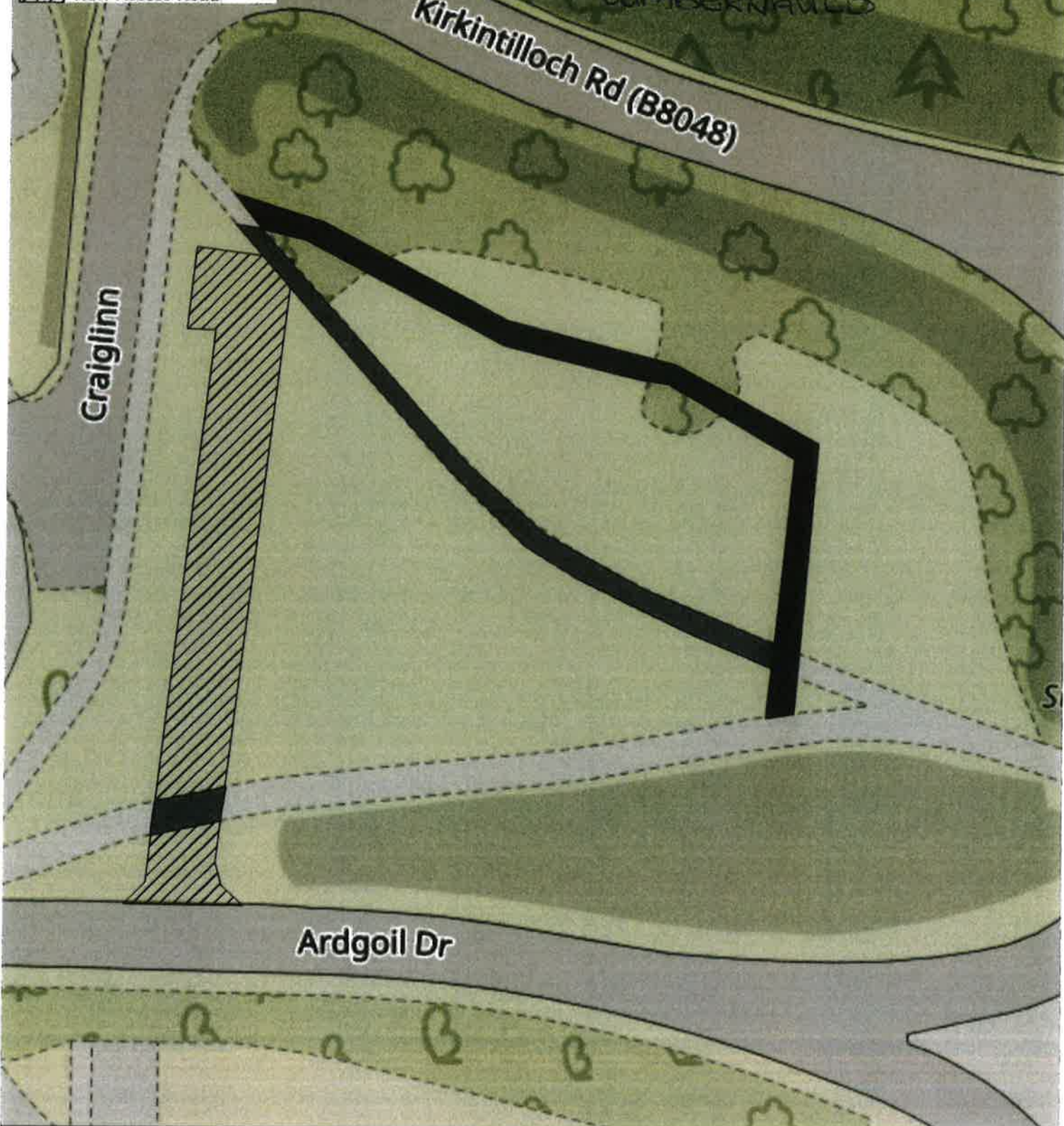
